An organization cannot run a casino short even one volunteer. We did not have enough back ups and that posed a problem when a few people did not show up for their shift. It would also be helpful to bring increased awareness to the school community about what things are funded by the fundraising society. Another idea suggested was having a volunteer voucher for school fees. According to Nancy, we cannot support individual students with casino proceeds. Also logistically this would be difficult or not possible for the administrative staff to apply these vouchers. According to AGLC, volunteers cannot receive any remuneration so we cannot advertise any type of gift for volunteering, such as gift cards. A parent suggested we could contact other school councils in our area to exchange casino volunteers.

Nancy suggested that we consider changing our AGLC use of proceeds to some new and more relevant spending areas. She will look into this.
