School Digital Citizenship Plan 2024-2025

During the 2024 – 2025 school year, students at Bob Edwards School can utilize laptops, Chromebooks, desktop computers, online applications, and other digital resources. Each student and parent/guardian are expected to read the Admirable Use Policy. Please contact your child's teacher or your school administrator if you have questions or concerns.

This Digital Citizenship Plan has been devised in collaboration with the administration, teachers, and students at Bob Edwards School. The following information and goals help to guide the school community around our plan to implement digital citizenship. These long-term goals are for the 2024-2025 school year, and we will continue to build upon them for long-term impact.

Relevant contextual information about your school and School Development Plan:

- Bob Edwards School is a middle school (grades 6-9) located in the community of Marlborough and is the designated French Immersion Program for students living east of Deerfoot Trail (northeast and sections of southeast Calgary).
- Approximately 14% of our students have a learning code.
- Our students speak 37 different languages in their homes, and 55% of our students are designated as English Language Learners. Many of our EAL students are new to Canada and have the added complexity of learning a second language, and if registered in the French Immersion program, there is further complexity in learning a third language.
- We have a full complement of athletic programs/teams offered throughout the school year. Students can participate in an excellent Band and CTF program.
- Bob Edwards is a bus receiver school for students from the Cityscape community who attend our regular English community program. All other students are not bus-eligible and therefore use Calgary Transit or other means to come to school.
- Each of our classrooms is equipped with a digital display (SMART Board or projector) to promote visual learning.
- Bob Edwards School has multiple mobile laptop carts that are accessible to teachers and students to aid in digital learning.
- Bob Edwards School also has a large print-based fiction and non-fiction book collection for students to borrow and read.
- Bob Edwards School has an Away for the Day Policy in addition to Ministerial Order (#14/2024), so students are expected to keep personal devices in their lockers and out of use while in the school for the duration of the school day. Students are expected to access school-owned devices for digital learning.
- All students and their families/guardians are provided with a paper copy of our Admirable Use Policy; they are expected to review this together and both students and parents/guardians sign this to acknowledge understanding and compliance.
- Our School Development Plan focuses on improving levels of student engagement in learning and supporting students around the development of improved literacy, French oral language development, numeracy, and well-being skills.
 - Our Achievement Goals are:
 - Literacy: Students will improve their achievement in reading comprehension skills.
 - French Immersion students will improve their achievement in oral French.
 - Numeracy: Students will improve their achievement in conceptual understanding of numbers, specifically in fractions and decimals
 - Well-Being: Students will improve their ability to effectively use self-regulation skills and increase their resiliency in learning and belonging.

- Relevant evidence and data that informs your Digital Citizenship Plan:

 At Bob Edwards School, we have a goal to foster positive relationships and a sense of belonging.

 It is important for students to understand their in-person persona and their online persona.

 - Students can encounter struggles to maintain a positive online presence.
 Students, staff, and parents will need to continue to build an understanding of how to promote safe and positive interactions in the online world.
